1. The School authority shall have to fulfill all requirements as required under section (10) of the Act and Rule 7, 8, 9, 10, 11, 12, 13 & 14 of the Rules.
2. The School authority shall follow the terms and conditions laid down in the Assam Non-Government Educational Institutions (Regulation and Management) Act, 2006 and Rules, 2007 and RTE Act, 2009.
3. The Non-Govt. Educational Institution under sub-section (5) of section (6) of the Act shall apply for final Registration alongwith copies of all documents and pay registration fee if not already paid.
4. The School authority shall constitute its managing Committee as per sub-section (e) of section 2 of the Act.
5. The School shall run as per Scheme of Management prepared under Section 14 of the Act and Rule 16 of the Rules.
6. The School authority shall have to complete the construction works on its own land (if not completed) before seeking final registration failing to which the order shall stand cancel.
7. The order will not accrue any financial liability to the BTC authority.
